

INTRODUCTION

The model 36-448 UniRip[™] Fence System includes an additional extension wing which can be assembled to Delta 10″ Contractor's Saw and 10″ Contractor's Saw.

UNPACKING

Carefully unpack the UniRip[™] and all loose items from shipping container.



- 12. Guide Rail End Caps (2)

ASSEMBLY INSTRUCTIONS

IMPORTANT: These instructions illustrate the assembly of Model 36-448 UniRip[™] Fence System onto Model 36-441 Series 2000 10" Contractor's Saw. The assembly procedure is the same for Delta 10" Unisaw, 10" Tilting Arbor Saw, pre-Series 2000 10" Contractor's Saw, and 10" Contractor's Saw II except where noted.





FOR SAWS EQUIPPED WITH CAST IRON EXTENSION WINGS ONLY

- 1. A hole must be drilled into the front and back of each extension wing to provide a more stable fence system.
- 2. Mark and drill a 13/32" diameter hole into the front and back side of each extension wing in the locations shown in Fig. 3.

FOR SERIES 2000 10" CONTRACTOR'S SAW AND 10" CONTRACTOR'S SAW II ONLY

ASSEMBLING EXTENSION WING AND SWITCH ASSEMBLY

1. Assemble extension wing (A) Fig. 4, to the saw table using three $7/16-20 \times 3/4''$ screws (B) and flat washers (C) [same as (5 & 6) Fig. 2].

2. With a straight edge (D) Fig. 4, make certain the extension wing (A) is level with the saw table before tightening three screws (B).

3. Loosely assemble switch bracket (E) Fig. 5, to the rear of extension wing (A) and fasten with $3/8-16 \times 1''$ long carriage head bolt through hole, then add flat washer, and hex nut (S) [same as (7,8 &9) Fig. 2].

FOR ALL SAWS LISTED ASSEMBLING GUIDE RAILS

1. Loosely assemble 1" long carriage head bolt, flat washer, and hex nut (S) Fig. 5 [same as (7,8 &9) Fig. 2], into the two pre-drilled holes in the saw table and extension wings. Place carriage bolts through holes, add flat washers then hex nuts.

NOTE: The on/off switch on Delta 10" Unisaw, 10" Tilting Arbor Saw, and pre-Series 2000 10" Contractor's Saw remains as illustrated in the instruction manual received with the saw.






2. Starting at the extreme right side of the right hand extension wing, carefully slide the guide rail (D) Fig. 6, onto the heads of the four carriage bolts (S), one of which is shown. **NOTE:** Make certain the heads of the carriage bolts are inside the channel at the rear of the guide rail. **IMPORTANT:** Slide the guide rail on the carriage bolts until the left edge of guide rail (D) is flush with the edge of the left extension wing (A).

3. Before tightening the hardware holding the guide rail to the saw table, proceed as follows: Beginning at the two sides of the saw table and using a square (F) Fig. 7, check to make certain the guide rail (D) is parallel with the saw table and extension wings. Tighten all guide rail mounting hardware.


4. Insert end cap (G) Fig. 8, into each end of the guide rail (D), as shown. Using a block of wood and hammer, gently tap end caps until they are completely seated into each end of the guide rail. **NOTE:** To avoid damage to the aluminum fence rail, do not use hammer directly against end caps.

5. Align holes in saw table and extension wings with four holes (H) Fig. 9, in rear guide rail (J) and fasten rear guide rail to saw table and extension wings with four one-inch long screws (K) through holes, then add flat washers (L), and hex nuts (M), as shown in Fig. 10. Flat edge of rear guide rail will face upward. **NOTE:** Blade guard and splitter assembly has been positioned at the rear of the saw for this illustration.

6. Before tightening mounting hardware, using a square (F) Fig. 10, check to make certain the rear guide rail (J) is 19/32" below the surface of the saw and extension tables.













ASSEMBLING RIP FENCE TO GUIDE RAILS

1. With the fence handle (A) Fig. 11, in the raised position, place the rip fence (B) onto the rear guide rail (C) so the hooked end (D) fits over the top ledge of the guide rail.

2. Lower the front of rip fence (B) Fig. 12, onto the front guide rail (E).

3. Lock the rip fence (B) Fig. 12, on the guide rails by pushing down handle (A).



ASSEMBLING SCALE TO GUIDE RAIL

1. Raise lock handle (A) Fig. 13, and slide rip fence (B) against one edge of the miter gage slot (C) as shown. Clamp the fence onto the guide rail by pushing down on lock handle (A). The edge of the fence (B) Fig. 13, should line up so it is parallel with the edge of the miter gage slot. If an adjustment is necessary, tighten or loosen either of two screws (D) Fig. 14, as necessary until rip fence (B) lines up with the miter gage slot.



2. Once the rip fence is aligned with the miter gage slot, raise the saw blade (E) to its highest position as shown in Fig. 15. Slide rip fence (B) against the saw blade (E) and lock the fence in that position by pushing down on handle (A).

3. Partially remove the backing (F) Fig. 16, from scale (G) as shown. Position scale under cursor (H) until "zero" mark on the scale (G) is directly under the cursor line (J). Lightly press down on scale (G) so it adheres to guide rail (K).

4. Continue to assemble the scale (G) Fig. 17, along the entire length of guide rail (K). **IMPORTANT:** Make certain the scale is positioned <u>straight</u> on the guide rail.



RIP FENCE OPERATION AND ADJUSTMENTS

The rip fence can be used on either side of the saw blade. The most common location is on the right side and is guided by means of guide rails which are fastened to the front and rear of the table.

1. To move the rip fence, raise the lock handle (A) Fig. 18, as far as it will go and move the fence to the desired position on the table. When the lock handle (A) Fig. 18, is pushed down, clamping action on the rip fence (B) should be adequate. However, if the clamping action is too loose or too tight, an adjustment can be made by equally tightening or loosening two screws (C) as necessary. **NOTE:** It will be necessary to remove the cursor (D) Fig. 20, to make this adjustment

IMPORTANT: THE BLADE FLANGE IS SET PARALLEL TO THE MITER GAGE SLOT AT THE FACTORY AND THE RIP FENCE MUST BE PROPERLY ALIGNED TO THE MITER GAGE SLOT IN ORDER TO PREVENT "KICKBACK" WHEN RIPPING.

2. Position the fence (B) Fig. 18, along one edge of the miter gage slot (F) as shown and lock the fence in that position. The edge of the fence (B) Fig. 18, should line up parallel to the miter gage slot (F). If an adjustment is necessary, proceed as follows:

3. Tighten or loosen either of two screws (C) Fig. 18, as necessary, until the fence (B) is parallel to the miter gage slot. **NOTE:** It will be necessary to remove the cursor (D) Fig. 20, to make this adjustment. Readjust the clamping action on the fence; if necessary, refer to **STEP 1**. Reassemble the cursor.

IMPORTANT: THE RIP FENCE MUST BE PERPENDICULAR TO AND LEVEL WITH THE SAW TABLE.





4. Using a square (G) Fig. 19, and a straight edge (H), check to see if the rip fence (B) is perpendicular to the saw table and that the rip fence body is level with the saw table. If an adjustment is necessary, tighten or loosen either of two screws (K), until the fence is perpendicular and level with the saw table.

5. Depending on the type of saw blade being used, the cursor (D) Fig. 20, may need adjustment to compensate for the blade thickness. To adjust the cursor, make a test cut on a piece of lumber and measure the finished cut, or you can place the rip fence against the blade as shown earlier in the manual. If a minor adjustment is necessary, loosen two screws (E) Fig. 20, and move the cursor (D) as necessary.

A WARNING: MAKE SURE RIP FENCE IS SECURELY LOCKED IN PLACE BEFORE **OPERATING SAW.**



